## Border Regions in Transition XI: Mobile borders

---

Contemporary borders undergo a permanent process of *de-territorialisation / reterritorialisation* but do not disappear, as had been predicted by some in the early 1990's. But the very location of the border is more and more open to question. This mobility will constitute the core issue/problem for our conference. Debordering / Rebordering processes involve selective and hierarchical processes on borderlands, and also multiply the forms and processes of materialization of the borders themselves. The material spatial inscription of borders and their growing *visibility* appear more and more difficult to define, as these become more fluid, open or fuzzy.

Firstly, the classical *significance* of fixed borders can be subject to a very real mobility when the natural discontinuities that ground it changes. The position of thalwegs, for instance, may evolve with the displacement of rivers bed. Climate change may also be responsible for topographical change, inducing for example the thaw of glaciers used to delimit boundaries, requiring a *renegotiation* based on the location of a summit point, a pass or a watershed.

But the notion of mobile border embodies a larger dimension when considering the evolution of border functions the location of which is no longer constrained to the limits of national sovereignty areas, but on the contrary tend to be pushed back and forth, projected, multiplied, diffused. The control function can notably be disseminated within a national territory, and no longer fixed at its entry point. Biometric, numeric, or smart borders illustrate that tendency. Borders are more and more organised as networks, therefore promoting the idea of reticular borders located within communication hubs. Whether in airports or train stations, of following mobile teams of customs officers, migrations and transactions are now controlled through "mobile borders".

Whether these changes erase borders or supplant strictly territorial dynamics with new reticular or network ones is subject to debate. The link between these new spaces and existing configurations such as extraterritoriality is another point of contention.

It therefore seems crucial to question the future of borderlands in this evolving context: some borders may appear break free of ancient constraints imposed by the boundary line, while others may loose the comparative advantages induced by the discontinuity. New dynamics emerge were borders tend to be pushed back and forth, where the linear limits tend to transform into an exchange zone or an area of collective projects. Border spaces play with the boundaries, transgressing, transcending, or moving them strategically.

Finally, numerous ephemeral spaces and territories come to light in the contemporary context, adding another dimension to the mobility of borders. Agricultural frontiers, temporary appropriations of public space constitute other power relationships with a society crossed by limits defined by a growing mobile nature.

The conference will therefore be dedicated to the comprehension of embedded and individualised, projected, fluctuating and ephemeral borders. But concentrating on the dissolution of borders only could appear cynical in *an era* which sees the multiplication of solid physical borders such as walls and fences. This is why we also wish to welcome communications which will analyse the link between the transformation of the border functions and the emergence of unseen barriers, considering these not only as resurgences of old military reflexes of national territory fortification. Walls themselves can be mobile, all expansionist move justifying their transfer.

Co-chaired by Dr. Anne-Laure Amilhat-Szary, Joseph Fourier University (Grenoble I) and Prof. Frédéric Giraut, University of Geneva, the conference will bring together around 200 international scholars who have been researching borderlands and de/rebordering dynamics around the world. The meeting is conceived as a unique occasion for those scholars to contribute to a conceptualisation of the Mobile border.

Following the Xth edition of BRIT which, for the first time in its history, met the Southern hemisphere (in South America, in Arica, Chile / Tacna, Peru). The goal of broadening the network membership beyond Europe and North America is pursued through the association with the ABORNE network (African Borderlands Research Network) and will result in the important presence of African borders specialists and stakeholders. The BRIT meetings bear the specificity of bringing together, on one set border, analysts and practitioners, thus setting the basis for very fertile exchanges.

A particular emphasis with dedicated lectures and field trips will be on the Alpine experiences in dealing with and going beyond inherited borders.

*Bien que leur mort, ainsi que celle des territoires, ait été annoncée au début des années 1990, les frontières constituent toujours une réalité prégnante. Elles sont marquées toutefois par les processus constants de déterritorialisation-reterritorialisation et d'ouverture / fermeture (« debordering-rebordering ») qui les sélectionnent, les re-hierarchisent mais aussi qui les rendent plus diverses dans leurs formes et leurs matérialisations. Ainsi, l'inscription spatiale de la frontière est de plus en plus difficile à définir, ce qui constituera le cœur du questionnement de notre colloque. Différentes tendances sont en effet à l'œuvre, qui produisent des frontières plus mouvantes, plus ouvertes ou plus floues.*

*Tout d'abord la frontière fixe, dans sa forme la plus classique, s'avère toujours sujette à une certaine mobilité lorsqu'elle secale sur des discontinuités naturelles dont la forme peut évoluer. Il en va ainsi des thalwegs qui fluctuent avec les évolutions des cours d'eau. Le changement climatique peut aussi être responsable de changement topographique avec la fonte de glaciers sur lesquels des frontières ont été établies, obligeant à revoir une frontière dépendant de la localisation d'un sommet, d'un col ou d'une ligne de partage des eaux.*

*Mais la notion de frontière mobile prend toute sa dimension si l'on considère que les fonctions frontalières tendent à dépasser la localisation sur les limites établies des aires de souveraineté nationale, pour être repoussées, projetées, multipliées ou diffusées dans l'espace. La fonction de contrôle peut notamment être disséminée à travers le territoire national, et non plus fixée à la seule entrée de celui-ci. Il en va ainsi des frontières biométriques, numériques ou « intelligentes ». Les frontières s'organisent conjointement de plus en plus en réseau, ce qui a fait émerger l'idée de frontières réticulaires, se situant aux nœuds de communication. Que ce soit dans les aéroports, les gares, ou suivant des équipes mobiles de douaniers, les migrations et les transactions sont contrôlées par des « frontières mobiles ».*

*Pour certains auteurs, ces dynamiques tendent à effacer la frontière, là où pour d'autres la logique réticulaire qui supplanterait celle du territoire créerait de nouvelles frontières, se trouvant loin du territoire national et ses limites administratives : elles sont projetées. On peut alors relier ce nouveau type de frontières au phénomène d'extraterritorialité.*

*Il semble essentiel de se demander ce qu'il advient des régions frontalières dans ce contexte : certaines peuvent se trouver soulagées des contraintes imposées anciennement par la frontière, mais d'autres peuvent perdre les avantages comparatifs induits par ces frontières. De nouvelles dynamiques voient le jour, où la frontière tend à être repoussée, où la ligne de frontière est transformée en zone d'échanges ou de projet. Les zones frontalières jouent donc sur la frontière, la repoussant au gré de leurs besoins.*

*Enfin, les nombreux espaces et territoires éphémères qui voient le jour dans un contexte postmoderne apportent une dimension supplémentaire à la notion de mobilité des frontières. Fronts agricoles, appropriations éphémères de l'espace public, autant de rapports de pouvoir au sein de la société tendant à créer des frontières toujours plus mobiles.*

*Le colloque sera donc d'abord consacré aux frontières embarquées et individualisées, aux frontières projetées, aux frontières fluctuantes et aux frontières éphémères, mais il pourrait apparaître assez cynique de s'interroger sur la seule dissolution de la frontière alors que notre époque atteste d'une multiplication des frontières physiques solides, telles que les murs. C'est pourquoi nous souhaitons également accueillir des participations qui analysent le lien entre la transformation des fonctions des frontières et l'émergence de*

*nouveaux murs, ne se contentant pas de considérer ces formes comme des résurgences d'anciens réflexes militaires de fortification du territoire national : les murs eux-mêmes peuvent être mobiles, toute visée expansionniste servant à justifier leur déplacement.*

*Co-présidé par Anne-Laure Amilhat-Szary, Université Joseph Fourier (Grenoble I / IUF) et Frédéric Giraut (Université de Genève) le colloque réunira 200 universitaires internationaux ayant réalisé des recherches sur les régions frontalières et sur les dynamiques d'ouverture / fermeture (« debordering-rebordering ») dans le monde. Cette rencontre représente pour eux l'occasion de contribuer à la conceptualisation des frontières mobiles.*

*Suite à la Xème édition du BRIT qui, pour la première fois de l'histoire du réseau, s'est déroulé dans l'hémisphère sud (en Amérique du sud, entre Arica, Chili / Tacna, Pérou), l'objectif d'étendre le réseau au-delà de l'Europe et de l'Amérique du nord se poursuit grâce à l'association avec le réseau ABORNE (African Borderlands Research Network) et s'illustrera par une présence conséquente de spécialistes et d'acteurs investis dans le fonctionnement des frontières africaines. Les rencontres du réseau BRIT ont en effet la particularité de réunir analystes et praticiens autour d'une frontière, condition d'échanges très fertiles. Un accent particulier sera porté sur des expériences alpines ayant trait à et dépassant les frontières héritées, avec des conférences spécialisées et deux excursions.*





### **Yves FLÜCKIGER**

#### **Vice-recteur de l'Université de Genève**

Professor Yves Flueckiger has studied sociology and economics at the University of Geneva, where he received his Ph.D. He is Full Professor at the Department of Economics since 1992. He is also member of the Board of the Applied Economics Centre (LEA) and of the Employment Centre. He has been also Vice-President of the Swiss Competition Commission between 2003 and 2007. Since July 2007 he is Vice-Rector of the University of Geneva.

His scientific interests include employment policies and working conditions in diverse labour markets. He has taught an International internship Course on Labour and Social Policies to Promote Decent Work organized by the

International institute for Labour Studies. He also teaches Labour Economics, Industrial Organization and Public Finance.

Yves Flueckiger has been Research Associate at the Universities of Harvard (USA) and Oxford (UK) and Invited Professor at the Universities of Lausanne, Fribourg (Switzerland) and Deakin (Australia). He has written numerous books and articles published in international reviews (among others, *The International Trade Journal*, *Economics Letters*, *Journal of Econometrics*, *Journal of Income Distribution*, *The Oxford Bulletin of Economic and Statistics*, *Swiss Journal of Economics and Statistics*, *Economie Appliquée*).

During last years, he received research grants from the Swiss National Foundation for Scientific Research for different projects concerning migrations, gender wage differentials, gender segregation and new forms of employment.



### **Laurent DAUDEVILLE**

#### **Vice-President Research, chairperson of Scientific Council, Université Joseph Fourier (UJF) de Grenoble**

Laurent Daudeville, 48 ans, est professeur des universités de classe exceptionnelle en mécanique / génie civil à l'Université Joseph Fourier (UJF) de Grenoble. Il a soutenu une thèse de doctorat de l'université Pierre et Marie Curie et une Habilitation à Diriger des Recherches de l'université de Marne-la-Vallée en mécanique des structures. Il est actuellement Délégué Scientifique au sein de la section des établissements à l'Agence d'Evaluation de la Recherche et de l'Enseignement Supérieur.



## Pierre François UNGER

### **Conseiller d'Etat, République et Canton de Genève**

Pierre-François Unger is Vice-President of the Geneva State Council since 7 December 2011. A member of the Christian-Democratic Party, he is currently in charge of the Department of Regional Affairs, Economy and Health. In 2001, he was elected State Councilor. Four years later, he was successfully reappointed for a second term, arriving first among all the elected members of government, and again in 2009 for his third and last mandate. Prior to that, he sat in the Great Council from 1993 to 1999 and presided his political party from 1996 to 1998.

In parallel to the pursuit of a political career, Pierre-François Unger practiced as a medical physician, his initial profession, a vocation that was triggered by a serious illness during his childhood years. Having achieved his medical diploma at the age of 24, he built up his experience and training abroad, namely in Paris. Upon his return, he was named head of the Emergency Ward at Geneva University Hospitals in 1986. He undertook to upgrade and modernize this medical service. In 1999, he was appointed professor of medicine.

Pierre-François Unger's commitment to mankind, in all its diversity and life stages, is evidenced daily by his friendly, outgoing manner and his drive for action. He is held in high esteem by his friends as well as within the field of his political activities.

Pierre-François Unger was born in Geneva on 21 August 1951 and is father to two grown-up boys.

For UNESCO she organized a five-year project on sustainable human settlement with a network of researchers and activists in over 30 countries; it is published as one of the volumes of the *Encyclopedia of Life Support Systems* (Oxford, UK: EOLSS Publishers). *The Global City* came out in a new fully updated edition in 2001. Her books are translated into twenty-one languages. She has received several honors and awards, most recently a *doctor honoris causa* from each Delft University (Netherlands), DePaul University (USA), and Université de Poitiers (France). She serves on several editorial boards and is an advisor to several international bodies. He holds M.A from the University of the North (now Limpopo) and a PhD in geography from Royal Holloway, University of London.



## Michel FOUCHER

### Institut des Hautes Etudes de Défense Nationale

Dr Michel Foucher is a geographer, diplomat and writer.

He is at present Director of Studies and Research at the Institute of National Higher Defence Studies (National Defence Academy in Paris). He is also Professor of geography and geopolitics at the Ecole Normale Supérieure, Paris, and adviser to the Division Peace and Security of the African Union (Addis Abeba).

Former Ambassador to Latvia (2002-2006), adviser to the French Foreign Minister Hubert Védrine (1998-2002) and Head of the Policy Planning Staff (1999-2002), special envoy to the Balkans and the Caucasus. In 2006 he served as Ambassador at large on EU affairs. He co-chaired the Franco-American working group on France-EU-US relations (2008-2009).

### Joëlle KUNTZ

#### **Journaliste, Le Temps, Geneva**

Jacques Lévy (1952-) is a geographer, full professor at the Swiss Federal Institute of Technology, Lausanne (EPFL). He is the director of the Chôros Laboratory and co-director of the Collège des Humanités.

He has been invited professor in various universities: UCLA, NYU, USP (São Paulo), L'Orientale (Naples), Macquarie (Sydney), and the Reclus Chair in Mexico City. He has been a fellow of the Wissenschaftskolleg zu Berlin. He has been invited as a keynote speaker in many congresses and conferences throughout the World.

His major concerns are social theory of space, urbanity globalisation, cartography, spatial development, and the epistemology of social sciences.

He has completed numerous research projects, including theoretical reflections, field studies on metropolises worldwide, and practical urban and territorial projects.
